MCCA Board of Directors' Meeting Minutes 10:00 a.m., September 9, 2015

I. Call to Order, Introductions, Attendance and Pledge of Allegiance

President William Blodgett called the meeting to order at 10:04 a.m. The attendees recited the Pledge of Allegiance.

II. Approval of/Additions to the Agenda

<u>Comm. Moody moved and Administrator Bill Collins seconded approving the agenda as presented. The motion was approved unanimously.</u>

III. Approval of Meeting Minutes

<u>Comm. Baldacci</u> <u>moved</u> and <u>Comm. Cote</u> <u>seconded</u> approving the minutes from the Board of <u>Directors'</u> meeting on August 12, 2015 as written. The <u>motion</u> was approved unanimously.

IV. Old Business

A. Updates on Jail Funding and/or Implementation of PL Chapter 335

No updates were given.

V. New Business

A. Nomination of an Additional Representative to the NACo Board of Directors

President Bill Blodgett requested nominations, specifically people who would be available to participate in NACo conferences. <u>Comm. Fowler made a motion to nominate Gary McGrane</u>. Comm. McGrane responded that he was interested in being the representative. <u>Comm. Cote seconded the motion</u>. After some discussion Comm. Blodgett asked for the vote. Eight were in favor and two were opposed. Gary McGrane is now Maine's second representative to the NACo Board of Directors.

B. Adoption of a Position Regarding a Proposed U.S. Department of Labor Rule Change that Would Increase the Salary Threshold for Employee Overtime Exemption

Administrator Scott Cole proposed that after the conversation at the meeting, the Board table this until the impact on counties could be studied. <u>Comm. Fournier moved to support NACo's position to extend the comment period 90 days. Comm. Baldacci seconded the motion, which was unanimously approved.</u>

C. Consideration of Hearing from Dr. Steve Kassels about His Novel, Addiction on Trial – Tragedy in Downeast Maine

Rosemary Kulow explained that Dr. Steven Kassels is board certified in Emergency Medicine and Addiction Medicine. The book was written as a mystery thriller to both entertain and educate through the depiction of the realistic struggles of addiction. Medical and behavioral aspects of addiction are woven into the intrigue of this thriller, which culminates in a riveting murder trial. Comm. Fowler suggested that MSA should hear his presentation. Comm. Cote said MCCA could host the talk and invite MSA so that both organizations could benefit. Comm. Blodgett stated that as there are no objections we will proceed. MCCA staff will set up a joint meeting and invite Dr. Kassels to speak.

D. Association Reports

MACCAM: Bill Collins reported the group would be meeting the next day at the convention.

MACT: David Parkman stated the treasurers association met this morning at the convention and had nothing of note to report.

MARP: Kathleen Ayers reported that this group also met this morning at the convention. The association continues to address challenges arising from changes in the laws and the current ever evolving e-filing system.

MECCA: Owen Smith reported that MECCA is co-sponsoring a risk management training with Gordon Graham on Oct 8th for Emergency Communications and others. The morning training is "Active Shooter" and the afternoon is "Ground Control for Fire Scenes."

MSA: Sheriff Liberty reported that funding distributions have gone out to county jails from the Department of Corrections. The amount of the distributions and how the amount was determined is not yet known. However, it is agreed that all counties will lack adequate funding. MOU's will be needed. Sheriffs are meeting in Augusta on Monday of next week to discuss how to deal with this. MSA has yet to take a position on whether to focus on the supplemental budget or completely revise the law in the next session. Sheriffs will need to work with Commissioners who control the budget. It is also unknown how pretrial defendants are counted in the distribution formula.

E. Corrections Report

No additional report was given.

F. Annual Convention Report

Office Manager Lauren Haven reported that the convention was going smoothly. Volunteers and members of the Convention Planning Committee met yesterday to prepare for the event. Final numbers may be available at the next Board of Directors' meeting depending on outstanding invoices and income.

G. NACo Report

Comm. Baldacci reported that Dr. Natalie Ortiz would be speaking today on the NACo study, "County Jails at a Crossroad: Examining the Pretrial Population and Pretrial Release." Sheriff Liberty stated that he is already utilizing her report in his management of the Kennebec County Jail. The talk will occur after lunch in the dining room.

VII. Other Business

Gary McGrane stated that Amy Fowler's term on the E-911 Council would expire soon. <u>Comm. McGrane moved to re-nominate Comm. Fowler to continue to serve on the Council.</u> <u>Comm. Cote seconded the motion and it was approved unanimously.</u>

VIII. Adjournment

<u>Comm. Baldacci made a motion to adjourn at 10:50 a.m.: Comm. Coward seconded the</u> <u>motion, which was unanimously approved.</u> The group adjourned to join in other convention activities.

Executive Director's Report September 4, 2015

Ethics Policy

The MCCA Ethics Committee has determined that a sufficient ethics policy already exists for the entire MCCA organization, and it is included in the adopted MCCA Personnel Policy. Copies of the Personnel Policy will once again be distributed to all board members and their proxies.

PL Chapter 335 - Jails Law

The MCCA Executive Committee held a conference call with Bill Whitten Friday, August 28th, at which time Mr. Whitten updated the Executive Committee about his progress in talking to legislators about the jails legislation and the jails funding situation. Mr. Whitten submitted the attached notes of his activities and the conference call. The bottom line is that the officers agreed that no new overall legislation will be developed and introduced for the next legislative session; but rather, the MCCA will focus on introducing a supplemental funding request in 2016. In the meantime, counties will work together to develop more appropriate legislation for the 2017 legislative session that will address the shortcomings of the current law.

NACo Membership

Congratulation, Maine! We now have 100% county membership in the National Association of Counties – the first time in history. 100% membership grants Maine an additional member on the NACo Board of Director, which ensures greater representation for our region and enhances Maine's clout in national policy-making. An additional perk from 100% membership is reduced conference registration costs for the new board member.

CONFERNECE CALL

8/28/15

Attendees: Tom Coward, Bill Blodgett, Peter Baldacci, Bill Whitten, Rosemary Kulow, Lauren Haven.

Bill W updated group on conversations: Had not been able to contact Ricky Long of CJPS

Catherine Nadeau of CJPS and one of the "authors" of current bill, felt she owes us the money up to 14.6 million and will do all she can to get it.

Senator Hamper of Approps. Agreed with Nadeau's assessment and said there is a surplus in revenue and this would be a top priority for him also.

All agreed to work on finding a method to get the supplemental funding.

Comm. Fitzpatrick of DOC trying to get the funding out in the next two weeks, question is what is that based on? 12.1, or plus surcharge funding, if so, less the \$225,000 for admin. Costs?

All agreed to NOT attempt any legislation in the next session and try to get 195 and Thibideau bill (carried over from last year) killed in committee, with no changes to current legislation. Let the counties work it out over the next year from now.

SINCE THIS CALL:

Peter Crichton has spoken with Comm. Fitzpatrick and found:

He reversed his understanding of the interpretation of who gets credit for the inmate, to the SENDING jail, this amounts to about \$20 per inmate.

This has caused Cumberland (and likely others) to review our policy and likely send back all inmates not paying a daily fee. In fact, it has been suggested we send OUT our own inmates to get credit and just close down.....

We just now received an explanation of inmate counting from Scott Ferguson, which I will forward also.

He did say however, that he expects us to make agreements between counties for inmate boarding....

So, I will continue to seek more understanding and go from there.

August 2015 Financial Report

Attached please find the monthly financial reports for the month of August 2015. The Balance Sheet shows total Assets/Liabilities & Equity at \$236,057.02. Debits to the bank account in August totaled \$15,633.48. The ending bank balance on August 31st showed \$238,199.99. This month the bank made a \$1.00 error in totaling one of the deposits, so they will credit \$1.00 to the checking account next month.

With about 67% of the budget year completed, we had collected \$207,128, or 84% of budgeted revenue by August 31st. In addition, last month we received the surplus distribution of \$47,845.72 from MainePERS, which was not forecast as budgeted revenue. Because we now subtract employer contributions from that pot of money, the August 31 balance remaining in that line was \$46,778. Through August 31st we had received \$40,174, or 73% of what is budgeted for Convention Income.

On the expenditure side, \$15,069 (6% of the total budget) was expended in August, for a total of \$133,507 (54%) expended year-to-date. We show that \$6,878, (20%) had been spent for convention expenditures as of August 31, 2015. See the *Profit & Loss Budget vs. Actual* report for additional revenue and expenditure details for the year.

MCCA finances are within budget, and there are no problems in any line item at this time. Please don't hesitate to let me know if you have any questions or would like to see anything different in the financial reports.

RE: Amendments to By-Laws

Dear Board Members.

Amendments to our Association's by-laws are now presented with hope of adoption at the 2016 annual membership meeting in January. Please refer to the draft document included with this memo.

In summary, these amendments will accomplish the following:

- clarify role and authority of Executive Committee in relation to Board of Directors
- <u>designate</u> the Board of Directors as sole agent to employ an executive director, or contract for executive director services, and to conduct performance evaluations
- <u>provide</u> the Association with option of procuring services of an executive director through employment or contractual relationships without prejudice toward either
- establish Board of Directors as a 16-member body with adherence to "one county/one vote" principle
- guarantee the right of eight affiliate organizations to speak at all Board of Directors meetings
- guarantee the right of eight affiliate organizations to vote on legislative positions

These changes are brought forward in a singular spirit of improving administration of Association affairs.

PROPOSED AMENDMENTS TO THE BY-LAWS OF THE MAINE COUNTY COMMISSIONERS ASSOCIATION

To Be Introduced at Board of Directors Meeting: Wednesday, October 14, 2015

• To Be Considered at Annual Membership Meeting: Wednesday, January 13, 2016 (or other date as may be scheduled)

ARTICLE I. NAME AND PURPOSE

Name

<u>Section 1.</u> The name of this organization shall be Maine County Commissioners Association, Inc., hereinafter called the "Association".

Purpose

<u>Section 2.</u> This Association shall be a nonpartisan organization serving Maine County Government, whose core functions are:

- a. To strengthen the role of county government in Maine by maintaining a comprehensive and robust advocacy role in the state and federal legislative, administrative and regulatory process.
- b. To enhance management of county government by providing quality member services for all Maine counties.
- c. To provide programming, services, information and education that supports member services for all Maine counties.
- d. To promote public awareness of the vital role of county government.
- e. To promote cohesiveness among the counties and facilitate and promote interaction among internal and external groups who have interests or programs that impact county government.
- f. To ensure professionalism and sound business practices in the management of the Association.

<u>Section 3.</u> The means of achieving this purpose will be by carrying out a comprehensive program in the areas of planning and research, publications, legislation and uniform administration for county government.

ARTICLE II. MEMBERSHIP

Eligibility Section 1. Membership shall be open to each of the sixteen

counties in the State of Maine.

Active Members Section 2. Active membership shall include all counties whose

current dues are paid, or which are not more than three months in

arrears.

ARTICLE III. ORGANIZATION

Authority under State Statute

Section 1. The Association is recognized in Title 30-A, Section 909 MRSA as a County Advisory Organization, and a nonprofit eligible to receive federal grants or contributions.

Board of Directors

<u>Section 2.</u> The Association shall have a Board of Directors made up of the following:

- a. One County Commissioner from each member county who shall be elected in accordance with Article IV, Section 1 of these By-laws, and
- b. One representative from each of the following organizations, chosen by those organizations, and whose names are submitted to the Board of Directors at least two weeks before the annual meeting:
 - Maine Association of County Clerks, Administrators and Managers
 - Maine Association of County Treasurers
 - Maine Sheriffs Association
 - Emergency Management Agency Directors
 Association
 - Maine Registry of Deeds Association
 - Maine Jail Association
 - Maine Association of Registers of Probate
 - Maine Emergency Communications Directors
 Association

Officers

<u>Section 3.</u> The officers of this Association shall consist of a President, a Vice President, and a Secretary-Treasurer, who shall be elected from among the members of the Board of Directors.

a. The President shall preside over all meetings and be a responsible ex-officio member of all committees. He/She shall execute any contract entered into by the Association

and shall have the general powers of supervision and management usually vested in the president of a corporation under the laws of the State of Maine, <u>unless</u> otherwise enumerated herein or defined by resolution of the Board of Directors. She/He shall see that all orders and resolutions of the Association are carried into effect.

- The Vice President shall perform the functions and the duties of the President in the absence or disability of the President.
- c. The Secretary-Treasurer shall perform the functions and duties of the President in the absence of the President and Vice President and shall insure that a full and accurate account of the receipts and disbursements of the Association is kept and that a full record of proceedings is kept.

Officers and Board Authority

Section 4. The officers and Board of Directors shall have control and management of this Association between membership meetings, shall hold and manage all property of this Association and shall be solely empowered to employ or contract for an Executive Director and related support services.

The Board of Directors shall periodically review the performance of the Executive Director.

Staff <u>and</u> <u>Administrative Support</u>

Section 5. An Executive Director shall manage the affairs of the Association and otherwise provide administrative support under the direction of the officers and directors and on such terms and at such salary as may be prescribed by agreement and as may be identified in the annual budget, they may from time to timeprescribe. The Executive Director with the approval of the officers may employ and terminate such employees as are necessary to transact the business of the Association, provided such employment is within the budget limits of the Association. The Executive Director shall be the Clerk of the Corporation.

Standing Committees

Section 6.

a. Executive Committee. The Executive Committee shall be composed of the Officers of the Association and the immediate Past President, and is chaired by the President. The Executive Committee shall transact routine and ordinary business between Directors' Meetings and report on any action taken at the next Directors' Meeting.

However only the Board of Directors It shall be responsible for interviewing individual candidates seeking employment as Executive Director, or representatives of firms wishing to provide for position of Executive Director functions and related administrative services to the Association, unless said interview responsibility is expressly delegated to an ad hoc committee created and charged by Board resolution. and recommend selection to the full Board. The Executive Committee periodically review the performance of the Executive Director.

- b. Budget and Finance Committee. The President shall annually appoint a Budget and Finance Committee composed of the Secretary-Treasurer and four Board members. The President may appoint additional members as necessary. The Budget and Finance Committee, with the assistance of the Executive Director, shall prepare an annual proposed budget for presentation to the Board at its December meeting.
- c. Legislative Policy Steering Committee. The Legislative Policy Committee shall be comprised of those who participate in the weekly legislative conference calls, drawing one vote from each of the sixteen counties plus one vote from each of the following organizations for a total of 24 votes:
 - Maine Association of County Clerks, Administrators and Managers
 - Maine Association of County Treasurers
 - Maine Sheriffs Association
 - Emergency Management Agency Directors
 Association
 - Maine Registry of Deeds Association
 - Maine Jail Association
 - Maine Association of Registers of Probate
 - <u>Maine Emergency Communications Directors</u> Association
- d. Nominating Committee. The President shall annually appoint a five-member Nominating Committee composed of Board members. The Nominating Committee shall solicit and review applicants for the various State entities requiring or seeking County representation, and propose nominees to the Board of Directors for approval. The President may appoint additional members as necessary.
- e. Convention Planning Committee. The President shall annually

appoint a Convention Planning Committee composed of two representatives from the host County and three other MCCA representatives. The President may appoint additional members as necessary.

Ad Hoc Committees

Section 7. With the exception of ad hoc committees created to interview candidates or firms seeking the position of Executive Director, the President shall appoint such ad hoc committees or special committees from time to time as the President or the Board of Directors deem necessary for the proper conduct of the affairs of this Association. No committee so appointed shall be authorized to create any financial liability unless it first has been approved as to its purpose and amount by the Board of Directors.

ARTICLE IV. ELECTIONS AND TERMS OF OFFICE

Board of Directors Section 1. The Executive Director shall notify each County

Commissioner and the President of each Association named in Article III, Section 3 by December 1 of each year to caucus and elect a Director for the coming year from that county or that particular Association. The Chairman of the Board of County Commissioners of each county and the President from each Association shall inform the Executive Director of the Board's nominee at least two weeks before the annual meeting. The Executive Director will advise all County Commissioners and the President from each Association of the entire list of proposed

Directors at least one week before the annual meeting.

Officers and Nomination Section 2. Immediately following the election of the Board of

Directors at the annual membership meeting, an Officer Nominating Committee of three Directors, appointed by the President, shall caucus and recommend nominees for officers from among the members of the Board for a term of one year, or until new officers are elected. The annual meeting will exercise its prerogative of accepting the recommendations of the Officer

Nominating Committee or nominating and election other candidates for each office from within the Board of Directors.

Terms of Office Section 3. Officers and Directors will be elected annually to serve

one year terms or until their successors are elected. An officer shall not serve more than two (2) consecutive terms in any

particular office.

Vacancies Section 4. In the event of a vacancy or the inability of a Director

to serve, the respective county may appoint a new Director in the

same manner to fill the unexpired term. In the event of a vacancy in the office of Vice President or Secretary-Treasurer, the vacancy will be filled by appointment by the President, subject to the approval of a majority of the Officers and Directors. A vacancy in the office of President shall be filled by appointment by a majority of the Officers and Directors.

NACo Representative

Section 5. The Board of Directors shall elect a Commissioner from a county which is a member of both the National Association of Counties and MCCA to represent MCCA at the National Association of Counties. The term of office shall be two years, and the election shall be conducted in January of the even-numbered years. All directors may participate in the vote for the NACo Representative.

ARTICLE V. MEETINGS

Membership Meetings

Section 1. Any meeting of the general membership shall be held upon the call of the President or any five Directors at least three of whom must be commissioners. A quorum requirement for a general membership meeting shall be satisfied when a majority of member counties are represented by at least one Commissioner. Delegates to any membership meeting of this Association shall consist solely of County Commissioners from member counties currently holding office and representatives of the Associations named in Article III, section 2. holding office. Only Commissioners representing member counties of this Association are those counties which have paid current dues according to the assessment under Article IV of these By-laws may be heard in debate or may vote at any membership meeting.

Directors' Meetings

Section 2. Meetings of the Board of Directors and/or Officers shall be held anytime upon the call of the President or any five Directors, at least three of whom must be Commissioners. A majority of the Board of Directors shall constitute a quorum for the discharge for business. It shall consist of at least nine Commissioners. An agenda shall be submitted through e-mail or regular mail by the Executive Director, with the approval of the President, to the Officers and Directors at least five days before any meeting unless time does not permit at the discretion of the President. New items may be added to the agenda at any meeting if a majority attending so vote. Delegates to the Board meetings shall be duly elected Directors or their proxy.

A representative from any of the following organizations shall be allowed to attend all Directors' Meetings and also allowed to speak at any Directors' meeting at the discretion of the President:

- Maine Association of County Clerks, Administrators and Managers
- Maine Association of County Treasurers
- Maine Sheriffs Association
- Emergency Management Agency Directors
 <u>Association</u>
- Maine Registry of Deeds Association
- Maine Jail Association
- Maine Association of Registers of Probate
- <u>Maine Emergency Communications Directors</u> <u>Association</u>

Proxy Votes

<u>Section 3.</u> Any Director who must be absent from a meeting may be replaced as follows:

- a. In the case of a Commissioner, Bby a Commissioner from his County designated by him the Director or, if no other Commissioner is available, by an officer or employee of the county, designated in writing by the Board of County Commissioners to vote in his the Director's place.
- b. In the case of a Director from an Association named in Article III, section 2, by a member of that association designated by the Director in writing.

Annual Meeting

Section 4. There shall be an annual membership meeting of the Association held in January of each year. The place of the annual meeting shall be determined by the Board of Directors.

Minutes

<u>Section 5.</u> Minutes of all meetings shall be sent to all Commissioners by the Executive Director by e-mail or regular mail as soon after each meeting as is practical.

Convention

<u>Section 6.</u> The Association shall hold an Annual Convention between September 1 and November 30 for all county officials, the purpose of which is to disseminate and share information in an effort to promote more effective and efficient county government.

ARTICLE VI. FINANCES

Budget & Dues

<u>Section 1.</u> At the regular December Board meeting, the Budget and Finance Committee shall present a method of dues assessment

and a budget for the following year for review and amendment as necessary. The Committee shall then present it for adoption at the January membership meeting. When a budget and a method of assessment have been adopted at the aforesaid January meeting, the dues for the ensuing year shall be considered assessed. Counties may opt to make two bi-annual payments of said assessments, one in January and one in July of the budget year.

Reports

Section 2. The Executive Director shall assist the Secretary-Treasurer in receiving and disbursing all monies of this Association at all times and shall submit at each annual meeting, or any other meeting if so requested, a report of all receipts and disbursements during the preceding year or any period thereof.

Audit or Review

Section 3. The accounts of this Association shall be audited at least once every two years by a competent accountant and may be annually reviewed in the opposite years by such or other person or persons to be selected by the Officers and Directors.

Bond

Section 4. If so established by contractual terms, the Executive Director shall furnish a satisfactory surety bond or such other instrument in an amount to be fixed by the Officers and Directors. the premium of such bond to be paid out of funds of this Association.

ARTICLE VII. INDEMNIFICATION OF DIRECTORS AND OFFICERS

Section 1. Every Board Member and Officer of the Association shall be indemnified by the Association against all expenses and liabilities including the settlement thereof, and including counsel fees reasonably incurred by, or imposed upon such Board Member of the Association of Officer in connection with any proceeding to which he or she may be a party or in which he or she may become involved by reason of his or her being or having been a Board Member of the Association, whether or not he or she is a Board Member or Officer at the time such expenses and liabilities are incurred, to the fullest extent provided by law.

The rights to indemnification granted hereunder shall not be deemed exclusive or any other rights to indemnification against liabilities or the advancement of expenses to which such person may be entitled under any written agreement, board resolution, vote of members, statutes, or common law. The Association may, but shall not be required to, supplement the right to indemnification against liability and advancement of expenses under this Section by the purchase of insurance on behalf of any

one or more of such persons, whether or not the corporation would be obligated to indemnify such person under this Section.

ARTICLE VIII. AMENDMENTS

Signature: Attested by Executive Director

Procedure	Section 1. These By-laws may be amended at the annual membership meeting or at any other membership meeting by a majority vote of all Commissioners present, provide the proposed amendments shall have been sent by ordinary mail or e-mail to all Commissioners of members counties and Directors of the Associations at least twenty days prior to such meeting.							
Effective Date	Section 2. Amendments shall become effective immediately after being formally voted.							
ARTICLE IX. DISSOLUTION	<u>ON</u>							
Procedure	Section 1. In the event of dissolution of the Maine County Commissioners Association, Inc., all its assets are to be prorated and returned to the participating counties in proportion to the amount of dues paid by each, after all obligations have been discharged.							
ARTICLE X. SEAL	Section 1. The Seal of this Corporation shall be a wafer seal stating on the face of it, Maine County Commissioners Association, Inc., Augusta, Maine 1968.

September 2015 Financial Report

Attached please find the monthly financial reports for the month of September 2015. The Balance Sheet shows total Assets/Liabilities & Equity at \$226,240.50. Debits to the bank account in September totaled \$17,888.27. The ending bank balance on September 30th was \$226,103.39.

With about 75% of the budget year completed, 86% of *budgeted* revenue (\$212,842) which does not include the disbursement from the MainePERS PLD surplus fund had been received by the end of September. MCCA received a total of \$4,385 income in September.

On the expenditure side of MCCA's budget, a total of \$149,085 (60%) had been expended by September 30th. \$15,531 (6.3% of the total budget) was expended in September. See the *Profit & Loss Budget vs. Actual* report for additional revenue and expenditure details for the year.

By September 30th MCCA had received \$45,883, or 83% of what had been budgeted for Convention Income. This is about \$9,117 short of the budget projection. As of September 30th, \$10,089 (29% of the budget) had been spent on convention expenditures, with \$3,164 paid out in September. We will have a more complete picture of Convention finances next month after all Convention bills have been paid, including the >\$20,000 convention center bill.

Other than receiving less income from the Convention than anticipated, MCCA's overall finances are within budget. There are no other problems in any line item at this time.



As the President of the Maine Registry of Deeds Association, I submit the following comments regarding proposed rule number 2015-P157.

We are opposed to section .07 Mandatory Participation – Real Estate Transfer Tax for the following five reasons:

- 1) The Maine Revenue Service Real Estate Transfer Tax declaration form authorized under Title 36, MRSA, section 4641 is unique among Maine tax forms in that it is not filed with Maine Revenue Services directly; it is filed with the various Maine county Registries of Deeds. Since the tax was instituted in 1968, when a deed conveying real property is submitted for recording in a registry of deeds, it must be accompanied by the declaration form. The registry determines that the form is completed and computes and collects the tax. The registers deal with the public handling their questions and concerns. By the tenth day of the following month the registries submit the tax forms and the State's 90% share of the transfer tax collected to Maine Revenue Services. Under Maine statutes it is not the public, the attorney or the title company that is submitting the declaration form to Maine Revenue Services, it is the county. Requiring mandatory filing at the state level is in violation of existing statutes.
- 2) There is no mechanism at Maine Revenue Services to handle incorrectly filed electronic declaration forms. Currently if a deed is presented for recording with a paper declaration form, the registry works with the submitter to revise that form, if necessary, until it is acceptable for filing. If the form has been filed electronically with Maine Revenue Services and has a DLN number assigned to it, any revision of that form fails. Revisions to electronic forms are not possible. Both the registry and the submitting entity must reject the form on the MRS web site and start over. If either the registry or the submitter fails to access the site and reject the form, it sits in limbo forever. There is no one at Maine Revenue Services with the authority or computer supervisory capacity to assist either the registry or the submitter in

correcting or deleting the form. Almost every registry has forms currently sitting in limbo. Adoption of mandatory "filing" will multiply this issue uncontrollably. This situation should be addressed before proposing the adoption of this or any similar rule.

- 3) Since the declaration form is filed at the county registry of deeds level, the bulk of the work associated with these forms occurs at the county registry. With a paper submitted form, the registry staff reviews the form at the same time they review the deed. At the time that the deed is imprinted with the recording information, the declaration form is validated. Insert the form, push a button, validate the form and on to the next document in the recording stack. With a state "filed" form, the registry staff must leave the recording process, access the Maine Revenue Services web site, sign in, find the correct form from the list, manually enter book, page, instrument number, date, time of recording, amount of tax collected, submit the form, verify the form and finalize it. A process that takes 2 to 5 minutes per form. With approximately 50,000 forms filed annually statewide this is 1688 to 4167 man hours more per year for registry staff. This will quickly rise to the level of an unfunded mandate.
- 4) Currently, there are several registries that do not have either computer access or have decided not to access the Maine Revenue Services website and have no log in information. Obviously, this means that mandatory "filing" at these registries is impossible as staff cannot complete the required registry portion of the process. In addition, some registers are concerned about cyber security and fear that repeatedly accessing the state revenue web site will make the county more vulnerable in case of hacking of the state site or other cyber threat. Requiring county registries to acquire computer access and log in to the Maine Revenue Services website is perhaps beyond the scope of this proposed rule.
- 5) The public notice of this proposed rule contains the phrase "Impact on Municipalities Counties: None." This statement is completely false. As stated above this rule change will require more county staff time and will have a huge impact on registry procedures and time management. It will require additional county staff participate and frustration to revise incorrectly submitted forms. It may require acquisition of internet access for some counties and may rise to the level of an unfunded mandate. There will be a negative impact on counties.

For these reasons, the Maine Registry of Deeds Association and the several county registers of deeds request that section .07 of proposed rule 2015-P157 NOT be adopted.
