### 3. Approval of the 1/9/2013 Annual Meeting Minutes

• Motion to approve 1/19/13 minutes, Coward/Moody, unanimous

#### **New/Old Business**

- 1. Ron Smith and Roger Moody to talk about the audit, IRS Status, By-Laws, Section 125 Plan
  - Ron Smith discussed some points on transitioning from Howe & Cahill to MCCA
    - It was impossible for a 6 month audit he went back to Jan 1, 2011 (18 months)
    - Ron met with Malcolm to get the history of MCCA and Risk Pool connection. They will continue to have more meetings
    - Moving the money (\$60,000) from Risk Pool to MCCA needs a cost allocation plan for moving funds
    - For the IRS status he does not have all the history yet
    - Risk Pool is a stand-a-lone you have to be a member of MCCA to be a member of Risk Pool
    - o Ron's concern is there is not insulation between MCCA and Risk Pool
    - MCCA and Risk Pool share the same tax ID number need to learn more and clean this up
    - Ron suggested we look at the bylaws
    - Ron said Howe & Cahill has been helpful
    - Ron has been working on a Section 125 plan for employee benefits to allow tax savings. The cost was \$200.00 to set it up
    - Motion to engage RHR Smith to set up a Section 125 plan at a cost of \$200, Coward/ Underwood, unanimous
    - It was asked if the new Executive Director could look into this Steve suggested we cannot wait we have an employee now.
    - Steve asked should we formalize our relationship with Ron? Steve, Ron and Roger will meet and come back to MCCA board with recommendations
    - We will have copies of the audit for our next meeting
    - A motion was made to formalize our relationship with Ron Smith at an upcoming meeting McGrane/Fowler
    - All in favor 1 abstain- Chandler

### 2. Legislative Policy Committee Update- Bill Whitten and Steve Joy

- The legislative update summary will go out at 4:00 on Mondays following the Friday conf. call
- LD 82 The people's veto sponsored by Senator Thomas

#### 2 MCCA BOD Meeting Minutes

- Hearing was on February 6. On this bill we are moderately opposed. The committee analyst has some unanswered questions. This may be voted down by the committee and might get put back to the counties. It may be unconstitutional for the state to require counties to put this in their bylaws
- James Annis reported Piscataquis County Commissioners had an issue which was costly to put out to a vote. The Piscataquis County Commissioners reopened their original vote and rescinded it.
- Bill said Kate from MMA stated the cost is \$1 million for a state-wide referendum
- Paul Underwood said how can we be moderately opposed?
- Steve said the state and many of the municipalities are subjected to this. The counties are the exception
- Susan Black mentioned capping so you are not doing a people's veto on minor issues
- LD 397- UTs this is not printed we are only acting on bills printed
  - o John Simpson is back
  - o Steve said John is still getting free copies on the internet from his county
- LD 76 Inverse Debt Mark Dion's bill
  - Mark Westrum, Steve Joy and Bill Whitten testified on the bill
  - Mark said it's a unique capital debt services the language speaks to counties holding debt
  - We made our case not sure if it will pass
  - o Mark suggested to engage our legislators
  - Our capital needs are significant and presently there is no money for capital infrastructure.
  - Mark has met with Sawin Millet, the Governor and his council many times to request money for capital infrastructure.
  - We cannot get funds from municipalities and the state is not living up to its obligation
  - Dion's bill will go a long way to assist Mark Dion thinks it will have strong committee support
  - We need to talk to legislators on the Criminal Justice and Public Safety Committee and the Appropriations Committee
  - $\circ$  It was discussed to come up with a list of capital projects Mark Tausek had a list

- o Bill said we will discuss this on the Leg. Policy Cmte conference call on Friday
- LD 49- Deeds electronic payment
  - This is basically a housekeeping bill for the Registry of Deeds
- LD 60- 2 PSAPs
  - This bill is dead
- Owen Smith spoke on these next two bills
  - LD 275 Unfunded mandate from state for police and fire
  - LD 196 Question and answer for EMD.
  - The cost will be \$3 million to implement
  - The Bureau E 9-1-1 voted 5-3-1 to oppose
  - The Bureau is neutral
  - Bill Blodgett said there should be a fiscal note attached
  - Owen said it was not popular to have people from the state going to the centers
  - $\circ$   $\,$  Owen will send notes out from MECCA meeting on Wed.

## 3. Update on Executive Director Search- Peter Baldacci

- Peter said the committee is down to 5 good candidates who are:
  - Donnell Carroll, Linda Pagels-Wentworth, Rosemary Kurlow, Jeff Kobrock and Joe Pietroski
  - The committee is interviewing Joe Pietroski today at 1:00pm he was not available for the February 22 interview timeframe.
  - They had some good candidates and it was a difficult process
  - The salary range is \$65,000- \$75,000
  - $\circ$   $\;$  The committee will make their recommendation in March
  - Scott asked if we should have a policy of affiliations to deal with conflict of interest.
  - Peter said if a conflict develops we will deal with it

# 4. By-Laws change Composition of MCCA Board, 20 day notice. - Steve Joy

- Steve needs approval to send out a letter, taking the Associations off the BOD
- There was an on-going discussion on either keeping the Associations on the BOD or taking them off
- o Susan Bulay gave us some history on how the Associations joined the MCCA Board

- George asked if Norm Fournier's Committee could bring suggestions.
- $\circ$  Roger Moody agreed to work on this with Norm
- A motion to table, McGrane/Baldacci, 12-5 in favor
- Point of order table this until we hear back from the By-law Review Committee

# 5B. Maine Sheriff's Association nominee to the CWG
