I. Call to Order, Introductions, Attendance and Pledge of Allegiance

President Thomas Coward called the meeting to order at approximately 10:05 a.m. following the MCCA Risk Pool meeting. Attendees recited the Pledge of Allegiance and all present introduced themselves.

II. Approval of/Additions to the Agenda

III. Approval of December 12, 2018 Board of Directors' Meeting Minutes

IV. President's Report

President Tom Coward reported on the activities, progress and accomplishments of 2018 including the Newly Elected Official Training. He encouraged commissioners to work together to present a united force in advocating for counties during this legislative session and continue the success achieved in 2018 with State support of county jail funding.

VI. Nomination and Election of MCCA Officers

The Nominating Committee comprised of Comm. Norman Fournier, and Comm. Baldacci met to deliberate about the 2019 slate of officers. Comm. Blodgett was not able to attend the meeting. Comm. Fournier, representing the Committee, made a motion to nominate and Comm. Thomas Coward as President, Comm. Amy Fowler as Vice President and Comm. William Blodgett as Secretary-Treasurer. Comm. Gardner seconded the motion and it passed with a unanimous vote.

VII. Appointment of MCCA Legislative Policy Committee Members

President Tom Coward invited interested Board members to join the Legislative Policy Committee. All are welcome to attend and participate in conference calls which occur as needed during the legislative session. Executive Director Charles Pray will ensure new members are added to his distribution list for details about future calls and meetings.

VIII. Nomination of Two NACo Representatives

Commissioner Peter Baldacci explained MCCA currently has one representative on the NACo Board of Directors and another representative who is eligible to attend NACo meetings and lectures during conferences. He summarized some of the main features and benefit of the nationwide organization, touching on Stepping Up, the Discount Prescription Card Program, and the NACo sponsored Leadership Academy. President Coward requested he put together a one-page synopsis to remind county folks what is available to them. Office Manager Lauren Haven said there should be something similar on the NACo page of the MCCA website. Commissioner Gardner moved and Comm. Jabar seconded re-nominating Comm. Baldacci and Comm. Fowler as MCCA's two NACo representatives. The motion was unanimously approved.

IX. Approval of MCCA 2018 Budget Line Item Transfers

Comm. Norm Fournier, representing the Budget and Finance Committee gave a brief overview of the recommended line item transfers to close out the 2018 budget. The group reviewed the list of proposed transfers. <u>Commissioner Gardner moved and Comm. Fowler seconded approving the list with no changes. The motion was approved.</u>

X. Approval of the MCCA 2019 Budget

Comm. Fournier, again representing the Budget and Finance Committee consisting of Comm. Amy Fowler, Comm. Tom Coward, Comm. Norm Fournier and Admin. Pamela Hile, presented the proposed budget in which no changes were made after the December Board of Directors' meeting. The group reviewed the revised draft discussing in particular, the formula for membership dues and the Risk Pool assessment. After this discussion, <u>Commissioner Fowler moved and Comm. Baldacci seconded approving the budget with no further changes. The motion was approved with one abstention.</u>

XI. Reports

A. Executive Director and Legislative Report

Executive Director Charles Pray gave a status report of MCCA activities and the commencement of the 129th Maine Legislature. Governor Mills has nominated Randy Liberty as Commissioner for the Department of Corrections. This pick decision weighs in our favor as he has a county background with a good understanding of the challenges faced by county government. The group discussed the other items on Executive Director report by Charles Pray particularly in reference to new legislation, placeholding bills, and county jail funding.

B. Financial Reports

Office Manager Lauren Haven presented the December financial reports. She reiterated the tightness of the 2018 budget and the group talked about researching long-term funding solutions with consideration to the dwindling money market account. Lauren invited questions about the reports. Hearing none, <u>Comm. Fowler moved and Comm. Cote seconded approving the financial reports. The motion was passed with no opposition.</u>

C. Professionalism in Management Committee

Comm. Mike Cote reported on the success of the Newly Elected Official Training Day in December. Approximately thirty people participated in spite of winter weather conditions. Attendees appreciated the opportunity for this specialized education, and it's expected MCCA will continue to offer it in the future.

D. Association Reports

MACCAM: Admin. Bill Collins reported the association planned to meet on Friday, January 11th. They continued to work with the jail budget numbers with assistance from Admin. Bob Devlin.

MARP: Kennebec County Register Kathy Ayers reported on the implementation of the many intricate and involved changes in the probate code goes into effect in July. The extent of the impact has yet to be determined, however, an immediate concern would be a fee shift and new expenditures necessary to comply with the law. Many of the forms being used will need to be updated as well as computer system changes and training. All of these changes are considered unfunded mandates. The association planned to meet with the probate judges on January 25th to work together to achieve uniformity as they proceed with these changes. Ms. Ayers promised to keep MCCA in the loop as new legislation is developed.

MSA: Sheriff Ken Mason reported members of the Maine Sheriffs Association planned to stand shoulder to shoulder with commissioners and other county representatives to help change Maine laws for the betterment of all counties.

E. Annual Convention Report

Office Manager Lauren Haven reported the Convention Planning Committee met on Friday, December 7th to work on the details for the 2019 event. The next meeting was scheduled for Friday, January 11th at the MCCA offices. The meeting minutes for the December meeting were included in the agenda packet. She reported good progress was being made and they were looking into funding for a special keynote speaker.

F. NACo Report

The upcoming NACo Legislative Conference will bring together over 1,500 elected and appointed county officials to focus on federal policy issues that impact counties and residents. Maine representatives will have an opportunity to participate in educational sessions, interact with federal officials and attend congressional briefings and meetings. This event is scheduled for March 2 through March 6, 2019.

XIII. Other Business

The group discussed counties opting to join the opioid multi-county action suit.

XIV. Adjournment

President Thomas Coward invited a motion to adjourn at approximately 11:50 p.m. Comm. Fowler made the motion seconded by Comm. Cote, and the motion was unanimously approved. The group adjourned to lunch.

Executive Director's Report *February 13, 2019*

Director's Report

Mills' Administration:

Last Wednesday Bob Devlin and I met with Jane Boyden, who on behalf of Commissioner Figueroa, Department of Administrative & Financial Services, had called late Tuesday asking if I could meet the following morning so she could better inform the Commissioner and the budget team an understanding of the Budget Request we had submitted for Jail Funding for Governor Mills' biennium budget, which will have been released by the time we meet.

We walked her through the informational sheet we presented to the Legislature showing the funding and revenue sources and provided a brief history of the last decade with a briefer referencing to several older decadal changes, outreaches and on-going conversations the Court and other players in addressing the mix of those in incarceration easing the State prison system to mental health and drug addictions – providing a larger overview - Counties are serving the State in a larger arena than just housing lessor criminal inmates.

Correction Commissioner Randall Liberty, we have asked for a similar opportunity for a meeting in providing MCCA's budgeting request. From several Sheriffs they have either as individuals, or several in a group, have had conversations with him expressing MCCA's continue on-going efforts to provide effective and efficient services in the greater State's corrections process and need.

FY2019-20, 2020-21 Budgets

As noted above, Governor Mills will have released her budget before we meet this month with her addressing the Legislature on Monday, the 11th. I previously noted we've submitted a budget line request of \$36.6 million for the biennium, \$18.3 million for each year, as a holding figure until Counties can provide more accurately hard figures through MACCAM, which Kennebec County Administrator Bob Delvin has been spear heading.

The gathering of and presentation of the County Jail budgets data MACCAM presented last year was extremely helpful in showing Legislators not only the larger State-wide impact but how their own Counties figured into the overall mix benefited us, MCCA, MACCAM and the MSA in conversations

in the State House. It will be helpful if we remain consistent in our format for Legislators to better see and understand the information we provide them in presenting our case for the State's partnership in covering the services the Counties provide both the State and our citizens therein.

Individual counties have already been holding legislative delegation meetings, Cumberland just last Friday and non-member Franklin a few weeks ago. I do need to say, the Franklin County meeting, at least as reported, if actuate, did have some misrepresentation of part of the problems of jail funding being a bit of a skirmish between counties (the article is attached).

I have had direct conversation with Criminal Justice & Public Safety Committee chair, Rep. Warren, of Hallowell, (Kennebec) and received an email back from Senator Deschambault, of York, of having the Committee scheduling a day/ an afternoon where we, Counties, would be afforded an opportunity to present an overview of operating our jails and the process of meeting the funding requirements and options in covering those demands. These were loose conversations, talks continue to how large of a scope, how it (or they) may occur, as well as when is ongoing, a work in progress. *

Senator Breen attended the MSA Roundtable discussion last month with the Chief Justice and the Court system which we participated in as well, and Rep. Gattine, Senator Breen's Appropriations Committee co-chair, has been receptive anytime I have had conversations with him last year, which have continued after the session last fall and into the start of the current session.

I am seeking a new champion on the Appropriations Committee. With former Bangor Representative Aaron Frey being elected Maine's Attorney General we lost not only an individual who understood and appreciated the whole complexity of jail operations, having served on the Board of Correction and of courses, being on Appropriations, understood the roll of funding the breath of programs government needs to fund as well as the ones individuals want to fund.

Legislative Submitted Proposals

An Act to Properly Fund County Facilities Incarcerating Individuals Pending State Court Action (as a Concept Draft)

An Act Requiring the State to Fund 20.25 Percent County Jails and Holding Facilities

An Act to Amend Funding Limitation on Incarcerating Facilities Operated by Counties (Tax Cap)

An Act to Provide the Office of Substance Abuse & Mental Health Services Funds to Provide Services to Maine County Correctional Facilities: (establishes AMHS responsibility for Drug Treatment, Rehabilitation and treatment of individuals with mental illness being held in Correctional facilities)

An Act to Expand Medicaid Coverage for Individuals Incarcerated in Maine Facilities

An Act Requiring Maine Department of Correction to fully fund County Jails for individuals sentenced to County Jails for all Sentencing exceeding Six months and Individual Held for Parole Violations

A Resolve to Establish a Bond to Establish the Maine County Correctional Facilities Revolving Construction and Improvement Bond Fund: This resolve would establish a \$100 Bond Fund, Counties, if they so choose, could draw from to construct, repair or upgrade correctional facilities. The Debt will be the obligation of the County utilizing the Funds. There would be a Board establish to approve access which would include the State Treasurer or a representative, the Commissioner of DAFS or a representative, two County Commissioners named by the Maine County Commissioner Association or their representative, Two Maine Sheriffs named by the Mainer Sheriffs Association and (?)

Maine Sheriffs Association: The Maine Sheriffs Association's Roundtable follow-up: Nothing to report as of this time. The MSA hosted their Legislative Breakfast January 17th.

Maine National Alliance on Mental Illness: Executive Director Jenna Mehnert still seeks a workshop focusing on mental health and hopes the MSA and MCCA would participate. NAMAI is working with individual jails on a program, Stepping Up: Reducing Recidivism for People with Mental Illness, across the State.

Maine Municipal Association: As a Town Councilor, I, as a member of the MMA's Legislative Review Committee participated in their meeting reviewing Legislation. We had a few issues that overlapped where we differed and where we agreed. Examples, we differed on law enforcement taking blood samples at fatal automobile crashes, but agreed on another Bill dealing with Road Posting.

NACo: I will be attending the NACo Conference in Washington, DC March 2 to the 6th.



MAINE COUNTY COMMISSIONERS ASSOCIATION January 2019 Financial Report

Attached please find the financial reports for the month of January 2019. The Balance Sheet shows total assets and liabilities at \$198,608.80. This amount includes \$22,430 from the money market account for MainePERS employer contributions.

Debits to the bank account in January totaled \$22,430.55, and receipts of \$2,402.84 were credited to the account. The debits were from normal operating expenses during the month, and a few expenses left over from December. As the 2019 budget didn't plan for Elected Official Training expenses, funds were used from "Other Meetings" for event space and also \$500 from "Professional Services" for Gene Libby Tim O'Brien's presentation.

The deposits consisted of payments for the Elected Official Training, ads for the 2019 Directory and NACo endorsements. The *Profit & Loss Budget vs. Actual* report shows membership dues in the amount of \$141,043 although not all of these funds have been received, the invoices have been generated and sent, therefore QuickBooks reflects the payments are expected. Also please note we exceeded the budget goal of \$3,000 in Directory ad revenue by \$550.

The general fund checking account balance as of January 31 was \$35,235.70 as some transactions had not yet cleared. With 8% of the year elapsed, 56% of the \$257,062 budgeted revenue will have been received when all invoiced payments have been posted. On the expenditure side, \$21,857 or approximately 9% had been expended year-to-date.

Additional details of financial transactions appear in the *Profit & Loss Budget vs. Actual, Transaction Detail, Expenses by Vendor*, and *Profit & Loss Previous Year Comparison* reports. Educational Session Updates

NACo Public Retirement responded they would like to participate in a retirement option panel on Saturday Morning.

Maine Registry of Deeds wants to bring in a speaker for their group on Friday after lunch. This would probably not detract from any other speakers as this will be very specific to the Deeds and Probate groups. Others who are interested could attend as well.

The group talked about the possibility of Probate Judge Susan Longley coming to make a presentation on trusts and wills. This would go along nicely with the retirement option idea.

We could look into sessions for Sheriff's, Treasurers, and Human Resources. The committee discussed having a keynote speaker after lunch on Friday and then three concurrent sessions from 2:30 to 4:30. We could also schedule one session or two sessions in the morning while association meetings are in progress.

Entertainment

The online voting poll results were highly in favor of hiring Local Comedian Luke Hanberry for Friday night. He and his friends can do a one-hour show for \$1,500 which includes travel. We will offer them dinner before the show.

Saturday night, in following with the game activities in the afternoon we will have three games in separate rooms for folks to enjoy: Team Charades, Family Feud and Name that Tune. Lynn offered to organize one of the games. We can ask Todd Charles to do one – everyone had a great time in the past. Then we need one more person for the third game. After games we will roast smores and perhaps have a fireworks display. Lauren will look into costs for the smores activity.

Waldo County folks thought they might have a staff member willing to manage the scavenger hunt around the property.

Keynote Speaker

No update on Charlie's speaker from the Maine Development Foundation to give a talk on Economics in Maine.

The group talked about asking Travis Mills to speak; he usually gets \$5,000 some of which goes to his foundation for wounded veterans. Lynn thought he might give us a discount. Lauren said we'd have to come up with funding, but we might see if each county would like to kick in for it. She will try to get permission from the Board of Directors to send out an email about it to all the counties. She thought we should send a link to a video about Travis which might inspire people. If we scheduled Travis we could have Charlie's speaker after dinner during the opening ceremonies before the comedian. We would ask for a 20 minute time limit – half hour tops.
