III. Approval of the Agenda

President Steve Gorden asked if there any additions to the written agenda. There were none. <u>Comm. Gardner moved to approve the agenda seconded by Comm. Blodgett and the motion passed.</u>

IV. Approval of the Minutes

<u>Comm. Blodgett moved to approve the minutes from the Board of Directors' meeting on December 9th. The motion was seconded by Comm. Hobart and the motion passed with no revisions.</u>

V. Legislative Policy Committee

- A. Legislative Activity James Cohen and Clara McConnell from Verrill Dana
 All legislative committees have been appointed. The four bill titles being introduced by MCCA have been submitted including language for all. Jim is going through incoming bills to see if there might be interest and/or will likely impact counties. He will forward these to be discussed at LPC meetings and alert the group to any scheduled meetings or hearings for bills we are following.
- B. Governor's Budget By statute, the Governor's budget had to be revealed by midnight on Friday. Mr. Cohen shared the highlights. The group talked about the "rainy day" fund which is at the highest level it has ever been. Comm. Fournier said he was surprised at the amount of \$18,442,104 the Governor identified for jail funding in 2021, 2022, and 2023. This is much more favorable than getting the 15 million, and then having to beg for surplus funding every year. Everyone thanked Jim and Clara for their work in helping MCCA introduce their bills.

Comm. Gardner expressed a special interest in some law enforcement bills which may not seem applicable at first glance. He may bring these to the attention of the board for support. One upcoming draft he mentioned was LR 664 sponsored by Denise Tepler, "An Act to Require Utility Companies and Cable and Telephone Service Providers to Establish Permanent Liaisons with all County Emergency Management Agencies."

VI. President's Report:

President Gorden introduced and welcomed two new County Board nominees:

- Waldo County Commissioner Betty Johnson
- York County Commissioner Richard Dutremble

Both Comm. Johnson and Comm. Dutremble spoke for a moment and said they were glad to be on the Board of Directors representing their county.

President Gorden announced that MCCA had been invited to make a brief presentation at the State and Local Government Committee orientation scheduled to occur on January 25th or 27th. Also, he mentioned Senator King's office will remain closed until after the inauguration.

VII. Approval of the 2021 Maine County Commissioners Association (MCCA) Board of Directors

President Gorden invited a motion to accept the slate of county nominated directors with the addition of Comm. Vinton Cassidy as a proxy for Washington County. <u>Comm. Hobart moved and Comm. Gardner seconded the motion which was passed with no opposition</u>. Therefore, the 2021 Board of Directors are as follows:

VIII. Nomination and Election of MCCA Officers

As Chair of the Nominating Committee Norm Fournier was asked by President Gorden to present the Committee's recommendation.

A. Nomination and Election of the MCCA Officers

Comm. Fournier stated Comm. Steve Gorden took over as MCCA President last spring and was eligible to be re-elected for that position. Vice President Mike Cote was not re-elected as a commissioner and no longer qualified to hold the position. Secretary-Treasurer William Blodgett had termed out of his position. In consideration of Commissioners who regularly attend and participate in meetings, the Nominating Committee composed of Comm. Bill Blodgett, Comm. Sharyn Pohlman, and Comm. Norm Fournier proposed the following slate of officers:

Comm. Steve Gorden, President Comm. Brian Hobart, Vice-President Comm. Norm Fournier, Secretary-Treasurer

Additionally, the Committee requested Comm. Blodgett and Comm. Baldacci remain on the Executive Committee.

Comm. Pohlman moved and Comm. Bill Blodgett seconded the motion to cease nominations. The motion passed.

Comm. Baldacci moved and Comm. Gardner seconded approving the slate of officers as recommended by the Nominating Committee. The motion passed.

B. Nomination and Election of Two National Association of Counties (NACo) Representatives

Comm. Baldacci has been serving on the NACo Board of Directors and on their Policy Steering Committee. Peter still had another year as the Board voted last year and this position was a two-year term. Comm. Baldacci stated that we only have one NACo Board seat because Maine is no longer a 100% membership state, but we can still have one representative and an alternate. After some discussion, Comm. Baldacci made a motion to elect Comm. Sharyn Pohlman to serve as the second NACo representative and as an alternate. Comm. Erkkinen seconded the motion and it passed with no opposition.

C. Bylaws Policy Committee Chair Appointment

Comm. Fournier has been asked to look at and modify documents. There was a request for volunteers. Comm. Gorden agreed to help along with Comm. Johnson, Comm. Gardner, Comm. Dutremble and Admin. Scott Adkins. President Gorden thanked everyone for being willing to participate in the process.

 D. 2021 County and Municipal Detention Facility Advisory Committee Member - those interested please indicate to be considered.

Comm. Mike Cote had served on this committee and the Board of Directors needed to recommend a replacement. Jail standards were discussed. President Gorden asked if anyone was interested in volunteering. Comm. Baldacci nominated former Jail Administrator Bill Clark, but he declined. Admin Dawn DiBlasi suggested Comm. Gardner who accepted the after some discussion about the details of the position. Comm. Blodgett moved to approve Comm. Gardner for the seat on the Advisory Committee. The motion was seconded by Admin. DiBlasi and the motion passed.

IX. Officer Reports:

A. Finance-Treasurer: Bill Blodgett - Comments about the state of MCCA finances

Comm. Blodgett commented MCCA was in a good position at this point. Cutbacks in costs and the PPP loan boosting the budget, put us in a strong position for the year.

- B. Financial Report Lauren Haven
 President Gorden invited a motion. <u>Comm. Baldacci moved to accept the financial reports as written, seconded by Comm. Erkkinen and the motion was passed.</u>
- C. NACo: Peter Baldacci Updates on Federal legislation, national programs and resources Comm. Baldacci said NACo has scheduled a virtual legislative conference in March. One registration for each association will be at no charge. They are currently fighting for funding for counties. He said he would forward NACo information to his new alternate, Comm. Pohlman.

X. Committee Reports

- A. Standing Committees:
 - 1. Budget and Finance Committee Norm Fournier, Chair Approval of the 2021 Budget

Comm. Fournier spoke on behalf of the Budget and Finance Committee. He summarized the proposed budget which was 8.53% less than 2020, and highlighted the approximate 11% decrease of membership dues from 2020. The approved membership dues formula remains the same with an 80% base amount, plus 10% valuation, and 10% population. The total membership dues amount proposed was \$148,354 which was a decrease of \$18,336. Every county will see at least a thousand dollar decrease. No changes had been made since the budget was proposed and approved at the December meeting to be brought forward to the annual general membership meeting. Comm. Chris Gardner thanked the Committee for their efforts, saying the budget was moving in the right direction. Comm. Gardner moved to accept the 2021 budget as was approved and recommended by the MCCA Board of Directors at their December 2020, meeting. The motion was seconded by Comm. Baldacci and passed with a unanimous vote.

2. Legislative Policy Committee (LPC) Updates:

President Gorden stated the previous LPC chair, Comm. Fowler, was no longer on the Board of Directors and asked if anyone had an interest in the position. There were no volunteers.

a. Supplemental funding and 2021 Jail Funding Bill
 (An Act to Stabilize County Corrections) Copy of Bill enclosed.

Sheriff Todd Brackett explained the details of the new bill (LR 967 which is the revised version of LD 973). Fortunately, Charlotte Warren was still on board as a sponsor for the bill. They met with Mary Anne Turowski, Senior Policy Advisor/Legislative Affairs on the staff of Governor Mills. The main issue in the bill had been the coordinating council oversight would have been too much like the former Board of Corrections (BOC). However, the language had been changed and the groups involved were satisfied with the wording. At the request of MSA, Sheriff Brackett sought to clear this point with Ms. Turowski. However, Sheriff Brackett says, "It's a big deal to them, so the language is likely to come back in some form." We need to consider what we could propose as a compromise. We should be leading the discussion instead of waiting to react to it. It was a positive meeting overall. Comm. Gorden said having the three organizations working on LR 967 (973) MACCAM, MCCA, MSA was a step in the right direction while we work on the language and work out the details. The LR has been sent to the revisor. The group agreed we need to bring the committee a solution. Admin. Pamela Hile commented we've been working on jail funding for ten years and this is the closest we've been to having some solution and support to it. Sheriff's it would behoove us to explore it. Hate to see it collapse because we didn't attempt. Admin. Carrie Kipfer mentioned the 25% quarterly payment idea was not MSA's suggestion.

Comm. Fournier made a motion to propose a committee including two MCCA representatives, two MSA representatives, two MACCAM representatives. The motion was seconded by Comm. Baldacci. President Gorden said they would meet within a week and a half with Commissioner Liberty. The motion passed with one abstention. The group decided to meet on Friday to discuss it more. Admin. Dawn DiBlasi suggested we have representatives with both large and small jails. Norm and Steve agreed to represent MCCA.

b. MACCAM recommendations – Comm. Fournier asked what MACCAM was proposing. Admin. Kipfer said the group met last week with a good turnout. They looked at LR 967. As a group they supported eliminating the Coordinating Council. They preferred annual funding rather than quarterly. If this was not possible, they would work towards biannual payments with half of the funding. They want the tax cap 4% or LD 1 "whichever is less" line eliminated. They want the Department of Corrections (DOC) to be removed as it's not appropriate for the DOC to deal with the tax cap for the counties. They are very pleased the conversation is continuing.

The group talked about the per diem charge and discussed \$50 as the amount. A State sanction prisoner would be paid for by the state, (analyst language). There is a standing issue of the amount of time a person is held in a County jail.

3. Risk Management Pool Agency - Norm Fournier and Malcolm Ulmer

Comm. Fournier stated there was nothing else to report.

4. Affiliate Organization Committee Reports:

MACCAM (Maine Association of County Clerks, Administrators and Managers)

MACT (Maine Association of County Treasurers)

MARP (Maine Association of Registers of Probate)

Kathy Ayers mentioned several bills being presented which the LPC should be watching and be ready to be involved. The group is already working on the bill 736 to increase probate fees. Additionally, many of the bills need fiscal notes. LD 646 same entitlement adult guardianship was proposed last year with no monetary amount in the fiscal note which was causing a lot of new cases and more attorneys were needed to handle the cases. The board needs to be aware there is a constant effort for the state to take over the probate courts. Comm. Gorden mentioned there is faster service in probate court than in district courts. Ms. Ayers is working with MCCA Lobbyist Jim Cohen and the LPC to keep MCCA up to date on bills we should support or oppose.

13	An Act To Coordinate the Delivery of Individuals Committed to the Department of Corrections	This bill, sponsored by Sen. Deschambault, requires the Commissioner of Corrections or the commissioner's designee and the sheriff or the sheriff's designee to coordinate the date and time of delivery by the latter to the correctional facility designated by the former as the initial place of confinement of an individual committed to the Department of Corrections.
37	An Act To Amend the Laws Concerning the Retired County and Municipal Law Enforcement Officers and Municipal Firefighters Health Insurance Program (Emergency).	This bill, sponsored by Sen. Libby, amends language contained in Public Law 2019, chapter 446 governing contributions under the open enrollment provisions of the Retired County and Municipal Law Enforcement Officers and Municipal Firefighters Health Insurance Program. Currently, the law requires a person hired on or after October 1, 2019 to enroll no later than 5 years after hire, conditioned on the enrollment and eligibility requirements of the applicable health plan; this bill removes that condition.
