**Counties Connect America:** Strengthening a Nation Together

To help convey importance of this intergovernmental partnership and the role counties can play to help move this country forward, NACo created the "Counties Connect America" initiative. This initiative will utilize the 2016 U.S. Presidential election cycle as an opportunity to educate and collaborate with our



intergovernmental colleagues campaigning for the White House. NACo has developed a number of materials and resources for county officials to utilize during engagements with candidates on the campaign trail. NACo recently unveiled the Counties Connect America hub containing resources and information including a brochure with "Why Counties Matter Fast Facts" and a social media tip page with sample share lines and photo albums of county officials engaging Presidential candidates.

As we enter primary season, candidates are focusing much of their attention on first-in states like Iowa, New Hampshire, South Carolina and Nevada. National Water Quality Month reminds us to take a long, hard look at what households and communities are doing to protect sources of fresh water. According to the Audobon Society, "Each individual household may not produce enough pollution to force a beach closing or cause a fish kill, but the combined output of all the homes in a community can be severe. And, consider that about half of the U.S. population lives within 50 miles of a coastline where runoff flows quickly to the ocean. This is why watershed protection — attention not only to the body of water but the area that drains into it — is important."

The Environmental Protection Agency, which reports that 40 percent of the nation's waterways suffer water quality problems, has a detailed watershed database, which allows users to locate which watershed they live in and learn about how polluted it is and what actions they can take to protect their regional water quality.

Clean Water Action offers a factsheet on what individuals and families can do to prevent water pollution from their homes, including:

- not using antibacterial soaps or cleaning products
- not flushing unwanted or out-of-date medications down the toilet or drain
- not putting anything but water down storm drains
- fixing leaks that drop from cars and putting liners in



Casco Bay CAN (Create Awareness Now) Coalition recently received the Greater Portland Council of Governments (GPCOG) Regional ReCOGnition Award and the National Association of Counties 2015 Achievement Award in Public Safety.

Casco Bay CAN is a regional initiative serving eight communities (Falmouth, Cumberland, Freeport, Yarmouth, Pownal, North Yarmouth, Gray and New Gloucester) within Cumberland County, based on volunteer participation, including a Law Enforcement Subcommittee, resulting in successful youth substance abuse prevention and intervention services.

## The Maine Emergency County Communications Association

The Maine Emergency County Communications Association AKA MECCA is the County Association of the County Regional Communication Center/911 Public Safety Answering Points (PSAPS). The Association was formed in 2003 to have a voice at MCCA and to represent County Communications in legislative issues. Thirteen of the 16 Counties have Regional Communication Centers which are also 911 PSAPS. Out of the total 26 PSAPS in the Stated the Counties operate 13 of them.

As regional centers we answer calls requesting police, fire, EMS and EMA response for emergencies. We also answer all 911 calls coming into the center. We then dispatch them out to the required agencies. Our Regional Communication Centers were the first "regional consolidation" efforts on behalf of towns, cities and counties and go back to 1999.

MECCA provides educational programs for dispatchers, testifies in Legislative sessions involving 911 issues and provides a solid network for cooperation among communication centers. MECCA is cosponsoring a day of training on October 8th. The morning training is, "Active Shooter" and the afternoon
