

In a recent interview with NACo Staff Writer Charles Taylor, MCCA Executive Director, Rosemary Kulow, said that taming state plans to assume more control over county jails was the top priority of MCCA during the state Legislature's 2014 session.

A law enacted in 2008 mandated that the local share of jail budgets be capped at a specified amount. Any shortfall was to be made up by the state Board of Corrections. However, jail costs have been "far exceeding the state allocations," said Ms. Kulow. This created what the Legislature termed an "emergency" in L.D. 1824, a bill "to provide additional authority to the state board of corrections (BOC)." The legislature created a task force, whose members included representatives from the MCCA, the Maine Association of Sheriffs and other stakeholders, which reached a compromise they all could live with. According to Ms. Kulow, MCCA will continue to work with the State BOC to create standards that will apply across the board to all the counties and their jail systems. *Click here to read more.*

After only six months of enhanced patrol coverage in Aroostook County, Chief Deputy Sheriff Darrell Crandall reports compelling results.

You may remember in the February issue of the MCCA newsletter, the law enforcement unit of the Sheriff's Office had undergone a significant transformation doing away with a call sharing agreement with the state police in place for the last 12 years. Under that agreement, Sheriff's Deputies patrolled one fifth of the county each week on a five week rotation. In January, the Sheriff's Office opted to resume covering the entire county daily.

A compelling bellwether of how this move has increased efficiency is the clearance rate, as tracked by the FBI. For every "index crime" reported to the FBI, they are also asked to report whether they were able to solve that crime. Index crimes are defined as homicide, rape, robbery, burglary, assault and theft. Sheriff Crandall is proud to report that the clearance rate for the first six months of 2014 was 67%, with the most currently reported Maine average being 32%. For comparison, their 2013 clearance rate was 37%. In addition, their overall arrests have increased by 40% over last year at this time.



Kennebec County Receives The Pro Patria Award

Maine Employer Support of the Guard and Reserve (ESGR), a Department of Defense office, announced Sheriff Randy Liberty and the Kennebec County Sheriff Office was honored with the Pro Patria Award in recognition of extraordinary support of its employees who serve in the Maine National Guard and Reserve. The ESGR's Pro Patria Award is presented annually by each ESGR State Committee to one small, one large and one public sector employer in their state or territory. Recipients have demonstrated the greatest support to Guard and Reserve employees through their leadership and practices, including adopting personnel policies that make it easier for employees to participate in the National Guard and Reserves. *~Read more here.*

Last April, the state legislature passed LD 1730 to assist the victims of human trafficking with support groups and funding. Since passage, local law enforcement agencies have participated in a joint task force aimed at identifying, investigating and prosecuting human trafficking, Oxford Deputies will be training in Portland to sharpen their skills in spotting signs
