



Citizen's Police Academy

Sheriff Timothy Carroll will be announcing the next date for the Knox County Citizen's Police Academy soon! The Knox County Sheriff's Office has found that education is very effective in gaining understanding and support from the Community. Through implementation of the Citizen's Police Academy; the Knox County Sheriff's Office can offer the Citizens of Knox County new insights into how Police, Corrections Officers and Dispatchers perform their duties, as well as how these departments serve the Community.



The Citizen Police Academy is a ten-week program where Citizens from the Community attend a three-hour class one night a week. Citizens who wish to attend may fill out an application online at knoxso.com/community or pick up an application at the Sheriff's Office. Completed applications should be returned to the Sheriff's Office, Monday through Friday between the hours of 8 a.m. and 4 p.m. Applications will be reviewed, and all attendees will be selected by the Sheriff and his Command Staff.

Classes will be taught by Deputies within the Knox County Sheriff's Office. The curriculum will cover such areas as History of Policing, Maine Law, Patrol Procedures, Criminal Investigative Techniques, Evidence Recovery, K-9 Program, Drug Recognition Expert Program, Etc. Each Academy participant will also receive basic hands-on training in Arrest Control, and Basic Hand to Hand Combat Techniques.



Attendees will have the option of riding with a Deputy on Duty and will conduct Shoot / No-Shoot exercises prior to graduating. The minimum participation to conduct the class is 10 with a maximum of 15. Space is limited so if interested, please apply ASAP.
