

Senate Legislation Would Reauthorize Major Transportation Bill

On May 12th, the Senate Environment and Public Works Committee, which has jurisdiction over the highway title of the surface transportation authorization bill in the Senate, released legislation to reauthorize the Moving Ahead for Progress in the 21st Century Act (MAP-21). The 150-page bill would authorize federal highway programs for six years at current funding levels, plus inflation.

There are several provisions in the legislation that counties should be aware of. Specifically, the bill would:

- · Provide a modest increase for programs that counties benefit from, including the Surface Transportation Program (STP)
- · Continue core highway program structure from MAP-21 which includes the STP program, National Highway Performance Program (NHPP), Highway Improvement Program (HSIP), and the Congestion Mitigation and Air Quality (CMAQ) Improvement Program
- Provide \$400 million annually for the Projects of National or Regional Significance Program to support a variety of projects, including transportation projects sponsored by local governments. Click here to read the full article.

Somerset Communications Supervisor Kelly McQuarry also received the Communications Supervisor of the Year Award for the State of Maine. Somerset is fifth in call volume out of 26 PSAPs (Public Service Answering Points) and were actually third in call volume for the month of March. With only 15 dispatchers, they cover all of Somerset County and 19 Municipalities in Kennebec County as well. The total population covered is approximately 142,000 with law enforcement coverage in Fairfield, Madison, Pittsfield and Skowhegan. Notably, it was the first center in the state to be recognized by the National Center for Missing and Exploited children.
