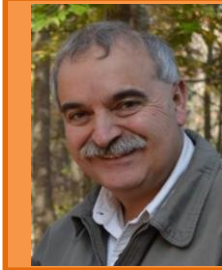

### Kennebec County Sheriff Named Warden

Kennebec County Sheriff Randall Liberty has been selected as the next warden of the Maine State Prison. Liberty, the county's sheriff for the past seven years, is set to take over the top position at the prison Sept. 28, according to a Department of Corrections news release. "I look forward to working with the professional and dedicated staff at the Maine State Prison," Liberty said. "I appreciate this opportunity and am honored by the trust and confidence that the governor and Commissioner (Joseph) Fitzpatrick have placed in me. I look forward to my continued service to the people of the state of Maine."

County Administrator Robert Devlin said in a prepared statement that Chief Deputy Ryan Reardon will step into the position, which is an elective office. Devlin described Reardon as "an experienced law enforcement professional who can quickly fill the void created by Sheriff Liberty's departure." [~Click to read the article by Craig Crosby.](#)



### Trailblazer Beverly Daggett

Beverly Daggett, an Augusta legislator who was the first woman to serve as Maine Senate president, passed away September 6 at the age of 69 in Lewiston after a long illness. She was elected the 111th Senate president Dec. 4, 2002, making her the first woman to ever hold the position. "Bev Daggett paved the way for women and children in our state," Speaker of the House Mark Eves said in a statement. "Her bipartisan leadership and steadfast service to her community inspired so many of us." She was active in the community and served as a Kennebec County commissioner and was a member of the Green Street United Methodist Church. She and her husband, Tom, raised three children.
